Welcome/Call to Order – Jim, WA3YLQ, Secretary

Roll Call Twenty- five ARO's and one XYL were in attendance.

Officer Reports:

President None

Vice President WA3YLQ offered a report on upcoming Club Meeting Programs. These include: August-Aero Mobile and Portable Opp's by Dan, WA3NFV. September-Stump the Experts. October-WS2K will present an updated program on operations with in-door antennas. Jim explained the Stump the Experts would be fueled by questions submitted to the Stump Us e-mail. Secretary Two second readings of new member applications were performed. A motion to accept the application of Al Moore, W3GD, was made by W3SEN. Seconded by WS2K. Motion carried. Welcome Al to our membership. A motion to accept the application of Mike Hoppes, W3MWH, was made by KS3Z, seconded by W3TFF. Motion carried. Mike becomes our newest member!

Treasurer Jim, KC3LXV, reported on the club's financial status. Our largest expenses for the year have been paid, and dues payments continue to be received as members catch up with 2020 dues obligations. We have not yet received a refund of the Hamfest Fee and deposit from the Fire Company. A motion to Accept the Treasurer's report as presented was made by KS3Z, seconded by KW3P. Motion carried. Thankyou Jim for the report.

Committee Reports

VE WA3YLQ reported that VE testing has been suspended for the rest of 2020. The Board does not want to jeopardize the welfare of our VE's, nor incur any liability. The plan is to look at the Pandemic situation in late fall and prepare a testing schedule for 2021.

Repeater KS3Z reported that the 2- meter repeater continues operation on the back-up power supply. K3UCI is repairing the main unit.

SEPPATN (KB3DEN absent) KS3Z reported that activity continues. He would like to see more stations handle and deliver traffic. Charles also asked that NCS operators who can not make their appointed schedule times should post such conflicts so other operators can make arrangements to fill in.

Old Business Presentation and approval of 2020 Club Budget. The Budget was posted on the reflector prior to tonight's meeting. The Budget Committee (KC3LXV, N3EOE and WA3YLQ) began work on the Budget in late April. The Board accepted the Budget and now the membership must approve it. WA3YLQ reviewed certain features of this "bare bones" budget. The fact that there will not be a Hamfest in October causes concern. Jim made special mention of Charles and Brian (N3EXA) and their work on developing an RF link for the control of the 2-meter machine. This link eliminates the need for the Verizon phone line, a savings of almost five hundred dollars per year (equivalent to the dues paid by nine-teen members). A motion to accept the Budget was made by KW3P, seconded by K3UCI. The motion was carried.

New Business NONE

Adjournment A motion to adjourn was made by NI2Q, seconded by W3SEN. Motion carried, meeting adjourned.

Program: There was no formal program for this evening. Meeting Zoom moderator, Dan, WA3NFV, called the roll and members were able to make informal comments. Casual rag chewing followed.
